In consideration of participating in the services of SUP Dogs, Inc. (SUP Dogs), I hereby acknowledge, agree, promise, and covenant with SUP Dogs and all persons, entities, employees, and agents on behalf of myself, heirs, assigns, personal representatives and next of kin:

1. ACKNOWLEDGEMENT OF RISK: I acknowledge, agree and represent that the lesson and subsequent unsupervised rental (open rental) I am about to engage in voluntarily, bears certain known risks and unanticipated risks which could result in injury, death, illness or disease, physical or mental damage to myself, my property, or third parties or their property, or the property of SUP Dogs Inc. I further acknowledge that I understand the nature of paddle sports and related activities and that I am qualified, in good health, and in proper physical condition to participate in such Activities and willingly agree to comply with the stated customary terms and conditions of participation.

2. ACCEPTANCE OF RISKS AND RESPONSIBILITIES: I fully understand that (a) paddle sports and related activities (“Activity”) involve risks and dangers of damage to personal property and serious bodily injury, including permanent disability, paralysis and death (“Risks”) to myself Risks to third parties; (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the “Releases” named below; (c) there may be other risks and social and economic losses either known or unknown to me or not readily foreseeable at this time, and I agree, covenant and promise to accept and assume all responsibility and risk for injury, death, illness or disease, or damage to myself, my property, arising from my participation in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT: I accept and assume all responsibility and risk for injury, death illness, disease, or damage to other third parties and their property arising from my participation in this Activity and agree not to sue SUP Dogs Inc, its instructors, employees, agents owners, officers, directors or contractors (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, injuries, damage to any person or any property or other damages on my account caused or alleged to be caused in whole or in part by the negligence of the “Releasees” or otherwise, including negligent rescue operations. I further agree that if despite this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement I, or anyone on my behalf makes a claim against anyone of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation, attorney fees, loss, liability or cost which may incur as the result of such claim. I further understand and agree to fully reimburse SUP Dogs for any damage caused to property of SUP Dogs as a result of my participation in the Activity. My Participation in this Activity is purely voluntary, no one is forcing me to participate and I elect to participate in spite of the Risks.

4. AGREE TO ABIDE: I agree to abide by SUP Dogs policies and agree to comply with all written and oral instructions in connection with participation in such Activity, and failure to follow such directions shall be grounds for termination of the Rental Agreement, without reimbursement or cancelation of fees paid or owed. I agree not to consume alcohol and/or drugs while participating in Activities.

5. Photo Waiver: I hereby agree that SUP Dogs has the right to take and utilize photographs and video of me participating in the Activity for the purpose of sale, promotion and advertising.

My signature below indicates that I have read this agreement and fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law. I understand that this is the entire agreement between SUP Dogs, Inc., its agents or employees, and myself and that it cannot be modified or changed in any way by the representation or statements of any employee or agent of SUP Dogs Inc or by me. If any portion of this Release is unenforceable, the remaining portions shall remain in full force and effect.
